## Your coronavirus (COVID-19) vaccination status

Depending on your age and vaccination status, you may be exempt from the requirement to self-isolate and take a Day 8 test upon your arrival in England from an amber country, provided you have not been to a red country in the 10 days prior to your arrival. If you are a participant in a formally approved COVID-19 vaccine trial you may also be entitled to this exemption.

Please check whether you meet the eligibility criteria for the exemption [here](#).

The exemption will only apply if you provide acceptable proof that you meet the necessary requirements during travel. Acceptable proof (i.e. of vaccination status or your participation in a formally approved COVID-19 vaccine clinical trial) is listed [here](#).

Please note that exemption from self-isolation and Day 8 testing only applies for the duration of your stay in England. If you travel onwards to Scotland, Wales or Northern Ireland, or a Crown Dependency, different rules may apply. You can check the travel requirements for [Scotland](#), [Wales](#) and [Northern Ireland](#).

## Self-isolation in the UK

If you have only been in low risk (green) list countries or islands in the 10 days before you travel, you do not need to self-isolate.

You must still take the 2 other coronavirus tests you booked for after you arrive in the UK, even if your Test to Release result means you can end self-isolation early.
